

Jackadder Lake Reserve Landscape Upgrade Round Two Consultation Outcomes

Background

The playground and exercise equipment at Jackadder Lake Reserve is due for renewal. As a part of the design process the City is engaging with the community to ensure any additional improvements considered for the reserve can be incorporated into the overall design in conjunction with the new playground and exercise equipment.

The proposed landscape plan is the outcome of two rounds of public consultation. The first stage of consultation was undertaken in late 2021 to gauge use of the reserve and to help prioritise identify needs and issues. Across both rounds of consultation, over 1,600 comments were received from more than 550 responses.

Proposed Landscape Plan

Outcomes of the initial round of public consultation were used to develop the landscape plan. Some key components of the proposed landscape plan were as follows:

Renewal of the playground

The proposed new equipment caters for the very young to the pre-teen demographics. The new main combination unit has over 50 activities. Natural play elements and accessible play items are also provided.

Renewal of exercise equipment

4 exercise stations are proposed in similar locations to the existing. The number of exercise activities will increase through a mix of both static and weight-bearing equipment.

• Revitalisation of the main picnic shelter

Improvements include creation of a basic kitchen facility (booking required), an increase in the number of picnic tables, and replacement of some roof sheeting with transparent panels to increase the amount of light within the shelter.

Additional shelters, picnic facilities and park furniture

Included in the plan are 2 new drink fountains, removal of 1 picnic shelter (from the playground entrance area), addition of 2 new picnic shelters, 6 new picnic tables (including the 2 in the main shelter), 4 additional park seats, and an additional BBQ near the playground.

Installation of a tennis hit-up wall

As the basketball/netball half court in Round 1 consultation received only 50% support, a tennis hit-up wall has been proposed instead. Given space constraints on the main reserve, a location at Tamarisk Reserve has been proposed.

Widening of the southern path

The narrow southern section of path, currently 1.5m wide will be widened to 2.5 m. The rest of the reserve which is mostly 2.1m wide will be increased to 2.5 m wide as ongoing path refurbishment projects are completed.

Realignment of the main circulation path away from the playground

This will reduce congestion and conflict between those using the main pedestrian path and those using the playground area.

Crossing points on Birchwood Ave

This was a significant need identified in the first round of consultation. Two crossing points will be installed. The first from the reserve to the shopping centre and the second from the reserve to the parking area at Tamarisk Reserve. The crossings points will consist of a median island pedestrian refuge.

Creation of turtle nesting areas

The provision of planted garden beds suited to turtle nesting will reduce turtle deaths by reducing the need for turtles to cross roads. Areas will be planted with low growing, native species.

Creation of wildlife refuge areas

Native reeds and plants will provide habitat and protection for local fauna. Areas with existing vegetation, particularly the bullrush on the north side of the lake, will be replaced with native plants over time. Logs will be added for turtle basking. The wildlife protection areas will be protected via low fencing where they are in close proximity to the main path.

Information signage

Allowance has been made for educational and information signage. This will include replacement of the bird species information sign at the south-east of the reserve and installation of an information sign for the model boat sailing groups.

Round Two Consultation Outcomes

The second round of public consultation commenced 25 October 2022 and concluded 25 November 2022 (4 weeks duration). Consultation was based on the proposed landscape plan (key points mentioned above) and a detailed plan for the playground area showing some of the proposed playground items.

The following methods were used to engage with the local community:

- Signs on site
- Letters and a copy of the plan sent to residents within 800m (2,480 letters sent)
- · Facebook posts on the City's page
- Project information page on the City's website
- Emails sent to residents that responded to Round 1 consultation

The City received 154 survey submissions and 19 email submissions (173 responses in total) during the second round of public consultation. 69% of survey responses were from residents of Woodlands and 13% from Doubleview residents, with the balance from other adjacent suburbs. There was a 13% increase in comments from local residents (Woodlands and Doubleview) compared to the results for the first round of consultation.

The overall survey result was as follows:

- 39.2% Supportive
- 46.4% Generally supportive, with some amendments
- 7.2% Unsure
- 7.2% Unsupportive

Amended Landscape Plan

As a result of comments received during the second round of public consultation, the following amendments will be made to the landscape plan:

- The tennis hit-up wall will be removed from the plan;
- A disabled parking bay will be created on the Jackadder Way verge near the playground;
- The nature play component within the playground will be reviewed (pending on available budget);
- Existing semi-mountable kerb to be replaced with mountable kerb along a section of Birchwood Ave verge. This will better facilitate verge parking and will be undertaken as future works;
- An additional turtle nesting area to be added to the northern end of the reserve; and
- A pram ramp to be installed to allow pedestrian access from the Jackadder Way footpath to the car park driveway.

Next Steps

The project will now proceed to final documentation and construction phase. Residents will be advised prior to work occurring on site with email notification (for those that opted to stay informed in the survey), and signage installed on site.

The City is intending to undertake the main playground renewal after Easter 2023, pending contractor availability. Stage 2 and 3 will follow in subsequent financial years, pending approval of required budgets by Council.

Consultation Responses

Enclosed is a detailed summary of public responses to the survey questions. Comments have been grouped according to the issues they relate to. This helps indicate community sentiment regarding specific elements of the proposed upgrade

Please note that comments have been edited to remove personal or identifying information and similar comments expressing a similar sentiment have been grouped.

There are enough play items for children, but the number of extra items proposed is too much. People like to have some space and room to walk and sometime to sit and enjoy the Park. In particular placing a Tennis Knock-Up Wall in the middle of Tamarisk Reserve is reducing a large space of land. This Reserve is used by people to exercise their dogs, and they have a lot of space to throw a ball for the dogs. They come to the Reserve, so they are not in the way of other people and children who are walking around the Lake. These people need the space and having a Knock-Up wall in the middle would reduce this space. Also parents sometime fly kites in the Reserve, and people play Soccer and other ball games in the Reserve, without disturbing the people who walk around the the Lake. There was a Tennis Knock-Up Wall build in Tamarisk Reserve about 35 years ago. Only a few children used the Hit -Up Wall for about six months, then it was abandoned. Eventually it was discovered that the land in the Reserve is not stable, as the Knock-Up Wall and even the Pre-Primary School building were subsiding and they had to be demolished. I understand the Pre-Primary School was demolished in 1993. All of this information should be on the City of Stirling records. If there was a very large demand for a Tennis Knock-Up Wall, I suggest it is placed to the South of the main Picnic Shelter that is there. This area is unused, and any families having a picnic would have easy access to the Knock-Up Wall. I note that the Jackadder Lake area is classified as a "Reserve". It was always my understanding that any area within the metropolitan area that was classified as a "Reserve" was an area primarily reserved for the preservation of flora and fauna in order for it to be enjoyed and appreciated by the local population, by visitors and tourists. t is clear therefore that the policy of the City of Stirling in regards to the lake was to encourage human activity at the lake rather than the preservation of wildlife. It seems possible to me that failing to plan primarily for the protection and well being of wildlife in favour of human activity might possibly be illegal. If the Parks and Landscaping planners employed within a Local Government Authority fail to see the need and appreciate the existence of nature and its wonders, then there is little likelihood of the general population being educated in this regard. What was a unique and beautiful bird habitat all those years ago has now been reduced to being an extremely noisy Public Park much to the disappointment of ratepayers who live on properties that look directly on to the lake and to the many other ratepayers who live in Woodlands and nearby suburbs. It should be noted that in other areas of the Metropolitan area many other nature reserves exist where the flora and fauna live in harmony with the human population and their dogs. The Lake Monger and the Point Resolution Reserves in Dalkeith are examples of this.	1	There is no requirement for Jackadder Lake Reserve to be reserved exclusively for flora and fauna preservation. It is a 'local reserve' in Local Planning Scheme 3. The Jackadder Lake Reserve Landscape Plan balances future recreational needs of the community, with the conservation needs of the lake.
The Jackadder Lake Reserve has been transformed over the years from being a beautiful and well known sanctuary for a wide variety of water birds and turtles to what can only be described as a Public Park catering to a wide variety of human interest such as sport and barbecuing and none whatsoever to the preservation of wild life. Other Local Government Authorities have managed to combine the preservation of flora and fauna with public activity and enjoyment.
