Tender Description:	<p>The City of Stirling (City) requires a suitably qualified and experienced synthetic turf specialist contractor for the design, demolition and installation for the replacement of existing grass turf bowling greens with a synthetic turf material similar or approved to the performance quality of Evergreen Gold/Supergrasses Ultra Plus Gold.</p> <p>The works consist of:</p> <ul style="list-style-type: none"> • Design allowance: Provide design drawings to demonstrate an understanding reflecting the works requested and required on site. Consider the material performance to ensure a specification is warranted for a minimum of seven (7) years. • Site possession: Access, pedestrian management and perimeter heras boundary fencing to the green inclusive of shade cloth to the northern face of the fence line to protect club members against dust during construction. • Site earthworks including boxing out, leveling, compaction and detailed edging. • Remove all existing fill from site, including existing brick edges and replace with limestone block. • Construct secondary retaining wall to allow for two (2) metre walkway into C green at the eastern side of new synthetic turf green. • Subbase build up and to within 3mm over three (3) meters. • Specify, supply and lay synthetic material. • City nominated contractors to undertake irrigation and electrical works after green walls are constructed.
