Tree removal is required when trees die, when structural problems cannot be corrected by pruning and when a tree's location conflicts with planned works.</p> <p>City Trees and its contractors are primarily responsible for:</p> <ul style="list-style-type: none"> <li>• <b>Scheduled (Sector) Pruning</b> - annual scheduled programme for street tree maintenance</li> <li>• <b>Citywide Tree Maintenance</b> - monthly allocation of tree maintenance tasks managed by the City Trees team.
