Note: Other than for owner builders, all residential building work valued over \$20,000 must be covered by Home Indemnity Insurance. However, Home Indemnity insurance is not required for "associated work" such as building only pergola, fence or swimming pool. It is compulsory for registered building contractors to take out a Home Indemnity insurance policy prior to applying for a building permit.
