Amending a Development Application

\$295

- Amend the approval so as to extend the period within which the development approved must be substantially commenced;
- To amend or delete any condition to which the approval is subject;
- To amend an aspect of the development approved which, if amended, would not substantially change the development approved.

If the initial fee was less than \$295 the original fee amount will be charged instead of \$295

Note: If the development has commenced or been carried out, the fee above, plus, by way of penalty, twice that fee.

Determination of Development Application – for an extractive industry

Application for change of use, or for an alteration, extension of use, or change of non-conforming use to which Item 1 does not apply, where the change, alteration, extension or change of use has not commenced.
