#### What is a Home Office, Home Occupation and Home Business?

Businesses run from home are classified into three different categories depending on the level of activity – Home Office, Home Occupation or Home Business.

**Home Offices** are not permitted to employ anyone not a member of the household and is not permitted to have any customers/trade visiting the property, signage or involve food preparation.

**Home Occupations** are permitted to have some customers/trade and signage. Home Occupations are limited to 20m² of floor area and may not employ anyone not a member of the household.

**Home Businesses** are permitted to employ up to 2 people not members of the household and is limited to 50m² of floor area. Some customers/trade and signage is permitted.

#### Do I need to provide any parking for my business?

Depending on the nature of the home business, additional car parking on the lot may be required. Any required car parking must be located within the site boundaries.

### Do I need my neighbour's permission to start my business from home?

Depending on the type of business, the proposal may require consultation with adjoining landowners:

- Home Office and Home Occupation does not require consultation
- Home Business requires consultation with adjacent landowners.

If the application relates to a strata property, you may require approval from your body corporate or other owners within the strata.

#### What businesses would not be considered appropriate to conduct from home?

Examples of businesses that are not considered to be suitable to be conducted from a residential property include:

- Businesses that require the provision of any essential service mains of greater capacity than normally required for a dwelling;
- Businesses that involve the fuelling, repair, wrecking, panel beating or mechanical maintenance to motor vehicles;
- Businesses that cause emission of light, noise, vibration, smell, fumes, smoke, vapour, steam, soot, ash, dust, grit, waste water or waste products.

#### Do I need Planning Approval?

A formal planning application for Home Office and Home Occupation is not required.

For Home Office Application, the Applicant is required to complete and submit a 'Home Office Form' to the City. If in the opinion of the City the proposal complies with the requirements of a Home Office, an approval letter will be issued and returned to the applicant.

Approval from the City's Environmental Health section maybe required if your proposed business involves penetration of skin (e.g. body piercing, tattooing, electrolysis) or storage, preparation, handling or packing of food. For further information contact <a href="Environmental Health">Environmental Health</a>.

A Planning Application for Home Business is required to be submitted prior to commencing the business from home.

### What Information is required to be submitted for a Home Office?

- 1. Home Office Form; and
- 2. No fee is required.

### What Information is required to be submitted for a Home Occupation?

- 1. No Development Application is required;
- 2. Health Approval maybe required if your proposed business involves penetration of skin or handling or packing of food


#### What information is required to be submitted for a Home Business?

- 1. Completed Development Application Form (LPS3 Form & MRS Form)
  - Signed by each owner of the property
  - Home Business Application Form
- 2. Development Application Fee
  - Please refer to the fee schedule to determine the relevant fee.
- 3. Certificate of Title (within 6 months)
- 4. Site Plan one copy Scale 1:200 showing:
  - North Point
  - Lot boundaries
  - Existing dwelling and other structures
  - Existing and proposed parking on the site
- 5. Floor Plans one copy Scale 1:100 showing:
  - Internal room layouts and highlight the location of the proposed home business.
- 6. Elevation Plans one copy Scale 1:100 showing:
  - Proposed signage.
    - NOTE: If no signage is proposed, elevations are not required.
- 7. Additional Information:
  - Written description of the business including:
    - The nature of the business;
    - Method of sales (if any);
    - Storage requirements;
    - o Equipment used (ie phone, computer);
    - Operating hours:
    - o Staffing requirements; and
    - Proposed number of customers to the site.


#### Site Plan



Note: Visitor parking must be provided within your lot boundaries.




#### Floor Plan
