NOTICE OF VENUE APPROVAL—SCARBOROUGH BEACH RESERVE

It is hereby notified for public information that the Chief Executive Officer of the City of Stirling, acting under delegation from the CEO under the *Environmental Protection Act 1986*, has made the following appealable decision pursuant to Division 7 of the *Environmental Protection (Noise) Regulations 1997*, in relation to an application for approval of a sporting, cultural or entertainment venue, namely the 'Notice of Venue Approval—Scarborough Beach Reserve' dated 10 March 2025—

- (a) Approval of the venue;
- (b) the imposition of conditions on the approval of the venue; and
- (c) the specification of the period of three (3) years as the period for which the approval has effect.

City of Wanneroo

BUSH FIRE BRIGADES AMENDMENT LOCAL LAW 2025

Under the powers conferred by the *Bush Fires Act 1954* and under all other powers enabling it, the Council of the *City of Wanneroo* resolved on 25 March 2025 to make the following local law.

1. Citation

This local law may be cited as the City of Wanneroo Bush Fire Brigades Amendment Local Law 2025.

2. Commencement

This local law comes into operation 14 days after the day on which it is published in the *Government Gazette*.

3. Principal local law

This local law amends the *City of Wanneroo Bush Fire Brigades Local Law 2024* as published in the *Government Gazette* on 28 June 2024. The principal local law is amended as follows.

4. Clause 4.5 amended

- (a) In subclause (1)(c)(iii) remove the words "Bush Fire Brigade Officer" and replace with "Elected Officer".
- (b) In subclause (2) remove the words "Bush Fire Brigade Officer" and replace with "Elected Officer".

5. Clause 5.3 amended

(a) In subclause (4)(a) remove the words "Bush Fire Brigade Officer" and replace with "Elected Officer".
