MINUTES OF THE SPECIAL MEETING OF COUNCIL OF TUESDAY 31 OCTOBER 2023 HELD IN CITY OF STIRLING COUNCIL CHAMBER, 25 CEDRIC STREET, STIRLING

DECLARATION BY NEWLY ELECTED MEMBERS

Honorary Freeman Rod Constantine read the Opening Prayer and Acknowledgement of Country.

In accordance with Section 2.29(1) of the *Local Government Act 1995* a person elected as Mayor is to make a Declaration in the prescribed form before acting in the office.

The Chief Executive Officer called upon Honorary Freeman Tony Vallelonga JP to conduct the Swearing in Ceremony of the Mayor.

Honorary Freeman Tony Vallelonga JP called upon Mayor Mark Irwin who made a declaration in the prescribed form.

Following his declaration, Mayor Mark Irwin assumed the Chair, and made the following acceptance speech:

"Thank you everyone for joining us this evening for this very special official occasion, where we acknowledge all candidates for their part in the election process and appoint the newly elected Councillors to their roles.

I would also like to thank our own Governance Team and the Returning Officer, as well as the broader group of staff involved in the lead up to, and including, Election Day. Your professionalism in the process gives the community confidence in our democratic system.

On Saturday 21 October 2023, the West Australian Electoral Commission conducted the election on the City's behalf for eight Ward Councillor vacancies and one Mayoral vacancy.

What an emphatic endorsement of the City's strong governance and leadership that every single Elected Member who stood for office was re-elected, with most being re-elected with a primary majority of over 50%. I was also re-elected with a 62% majority of the vote, including a majority of the votes across every Ward, showing confidence from our community in the work we're all doing as a team.

At the City of Stirling, Elected Members are very aware that the way we are seen in our community is only partly as a result of our own efforts. Last week, following the election results, I wrote to all the staff from Team Stirling, and acknowledged the part that they play, from our frontline services and outside workforce, to the Administrators and Coordinators, who all genuinely care about their role in delivering day in, day out for our community.



There are two new faces who join us in Chambers tonight, Councillor Rob Paparde and Councillor Damien Giudici.

On behalf of the Council and the community, I extend my sincere congratulations of your achievements and wish you all the best for the next four years. Positive, capable and passionate locals who will bring a variety of experiences and views to this table, making our team even stronger. Remember why you wanted to represent your community. Be vocal advocates for what you believe in, and challenge the things you want to see changed.

We are really pleased to have you here with us and we have every confidence you will represent your local communities with the same passion and determination that we have enjoyed with former Councillors Felicity Farrelly and Bianca Sandri, who resigned prior to the elections. Please join me in congratulating Councillor Paparde and Councillor Giudici.

Under the leadership of Stuart Jardine PSM over his 16 years as Chief Executive Officer, this organisation has become the undisputed leader in the local government sector. We are looked to by our peers for innovative ideas, and we are looked upon by other levels of government as a trusted partner.

As we've mentioned many times, the Executive Team, lead by Stuart, is one of the highest performing Executive Teams in the nation, producing our new Chief Executive Officer, Stevan Rodic, who we know has the capabilities and the cultural leadership to take Stirling into our next era. We are excited by what the future holds and wish to thank you, Stuart, Stev and all of Team Stirling for all that you do for our community.

As your re-elected Mayor, I will continue to work hard for our community. I will advocate for those who need a voice and to make decisions that will benefit our whole district. In accordance with Clause 8(2) of Schedule 2.3 of the *Local Government Act 1995*, the Mayor presided over the conduct of election of the Deputy Mayor.

The Mayor informed the meeting that he had received two nominations in writing for the position of Deputy Mayor, being:

- Councillor Suzanne Migdale
- Councillor Elizabeth Re

The Mayor called for any further nominations. There being none, the Mayor advised that nominations for the position of Deputy Mayor were closed.

In accordance with Regulation 11A of the Local Government (Constitution) Regulations 1998, ballot papers were prepared, with the nominated Councillors listed in alphabetical order. The Manager Governance authenticated each ballot paper by initialling it.

A polling booth and ballot box were made available to Elected Members, and a secret ballot was undertaken.

Honorary Freeman Rod Constantine PSM oversaw the counting of the votes for the position of Deputy Mayor.

In accordance with the Regulation 11F of the Local Government (Constitution) Regulations 1998, the Mayor declared Councillor Suzanne Migdale elected as Deputy Mayor of the City of Stirling for a two year term.



6. SWEARING IN OF THE DEPUTY MAYOR

The Mayor advised that Councillor Suzanne Migdale, who was unable to attend the meeting due to illness, will be sworn in as Deputy Mayor at the Special Council meeting to be held 7 November 2023.

Councillor Suzanne Migdale had prepared a brief speech, which was read out by the Mayor:

"To Your Worship the Mayor and Councillors.

At the time of writing this message, I do not know the outcome of tonight's deliberations. However, if this message is being read out, then you, as my peers, have honoured me with the position of Deputy Mayor. I'm deeply humbled by this privilege, and God willing, I will serve you with humility and to the best of my ability. Thank you, Councillor Suzanne Migdale."




