Interested in advising on design quality in planning?

The City of Stirling invites expressions of interest for the Design Review Panel. Submissions must be received by 5pm, Friday 27 August 2021.

Why does the City of Stirling need a Design Review Panel?

Design quality is important to the City of Stirling and allows solutions to be collaborative, gaining expert independent advice on the design quality of significant and complex development application proposals and strategic instruments.

Integrating design review into the planning system is a key component of the implementation and operation of State Planning Policy 7.0 – Design of the Built Environment.

What is the role of the Design Review Panel?

The Design Review Panel will:

- Attend regularly scheduled meetings at the City of Stirling Administration Centre, or via videoconference link if required.
- Provide independent expert design advice on various development proposals and strategic instruments against the 10 Design Principles within State Planning Policy 7.0 - Design of the Built Environment.
- Provide, through the Chairperson, independent, impartial, expert advice on design quality which will be presented to proponents, decision-makers and the community in a formal written report and recommendation against the 10 Design Principles of State Planning Policy 7.0 - Design of the Built Environment.
- The roles and responsibilities of the Chairperson and the Panel members are outlined in the City of Stirling Design Review Panel Terms of Reference.

The appointed panel of 15 members, with a minimum of 3 for any such meeting will be in place for a 2year term. Panel members are paid for attendance per meeting attended.

Who is eligible?

Suitably qualified professionals with demonstrated expertise in the following field/s:

- Architecture
- Heritage
- Landscape Architecture
- Sustainability and Environmental Design
- **Urban Design**

If you are a qualified, skilled and experienced professional from within these fields with the ability to analyse proposals against the relevant Design Principles you are encouraged to submit an expression of interest by submitting your CV and a Cover Letter in the form below. Please respond to the following supporting statements in your Cover Letter:

- Demonstrated expertise and knowledge within the field/s of architecture, heritage, landscape architecture, planning, urban design and/or sustainability and environmental design, relevant to the City of Stirling.
- Understanding and familiarity of the State and local planning framework.
- Skills to bring to the City of Stirling Design Review Panel.
- Direct experience with design review.
- Related qualifications.
- Current registration with their relevant professional body.
