Amending a Development Applications

\$295.00

- amend the approval so as to extend the period within which the development approved must be substantially commenced;
- to amend or delete any condition to which the approval is subject;
- to amend an aspect of the development approved which, if amended, would not substantially change the development approved.

*If the initial fee was less than \$295.00, the original fee amount will be charged instead of \$295.00*

Application for change of use, or for an alteration, extension of use, or change of non-conforming use to which Item 1 does not apply, where the change, alteration, extension or change of use has not commenced.

- more than 195 lots \$7,393.00
- additional inspection fee \$100.00 per inspection

*Note: each common property lot is counted as one lot.*

Strata Form 15 – Certificate of Approval for a strata plan of re-subdivision or consolidation:

- One to 5 lots \$65.00 per lot plus \$656
- 6 to 100 lots \$43.50 per lot plus \$981
- More than 100 Lots \$5,113.50
