# Accessible Stirling Awards



## What are the Accessible Stirling Awards?

The Accessible Stirling Awards are a City of Stirling initiative to recognise businesses in Stirling who have improved access and inclusion for their customers, clients or staff.

Access generally refers to physical access to the natural and built environment – buildings, recreational facilities, parks, bushland and footpaths – in addition to services, products and information.

Inclusion describes the situation in which all people are recognised as having something to offer and all differences are acknowledged and accepted.

The Accessible Stirling Awards seek to raise awareness and eliminate discrimination.

## Who can be nominated for the Awards?

Businesses located within the City of Stirling.

You may nominate businesses for initiatives which may include but not limited to:

- Improvements to the physical access of a building such as installation of a ramp or automatic door opener
- Widening aisles for ease of access for people using wheelchairs or mobility aids
- Provision of a lowered counter
- Providing information in alternative formats such as: large print menus or the use of photographs with text
- Training staff in customer service and communication
- Being an equal opportunity employer

## Who can nominate?

Anyone can submit a nomination – customers, community members, other businesses, even employees may self-nominate for an award. (If you are nominating a business, please gain permission from the Manager).

A maximum of one entry annually per community member or business is permitted.
